

Bowdon

In 1301 Peter de Brinington (or Brimington) clerk sued William de Stockport for the period that William was his bailiff in Bowdon. In 1297 he had taken a similar action against William (de Boole) the vicar of Bowdon. Peter was archdeacon of Chester.

17 kalends November (16 October) 1309 Ranulph de Torald deacon was presented to the vicarage of Bowdon by the prior and convent of Birkenhead after the death of Richard de Oldcroft. The ancient parish of Bowdon comprised
