Hamon le Ferryman

Hamon le Ferryman appeared against Henry Sidcokson in February 1310 to acquit him against the king of a sum of seven shillings that he levied from Hamon in the township of Crowton; against John son of Robert de Winnington junior to acquit him against the king of a sum of 10d; Robert de Bulkeley to acquit him against the king of a sum of 2s; Richard de Lostock to acquit him against the king of a sum of 2s; John de Legh to acquit him against the king of a sum of 2s; Roger de Leicester to acquit him against the king of a sum of 6d; Roger Toprond to acquit him against the king of a sum of 7s; and William de Wilbraham to acquit him against the king of a sum of 12d; Henry son of Ralph to acquit him against the king of a sum of 6d; Hugh son of Ralph acquit him against the king of a sum of 6d; Robert de Pulford acquit him against the king of a sum of 6d; William son of Perot to acquit him against the king of a sum of 6d; Hugh son of Bate to acquit him against the king of a sum of 6d; Reginald le Saltbearer to acquit him against the king of a sum of 6d; Margery le Harpersdaughter to acquit him against the king of a sum of 6d; and Jevan son of Ralph to acquit him against the king of a sum of 6d; all which moneys they should have acquitted him from the time that he was the king's bailiff for the town of Northwich, and which he had been instructed to levy by estreat of amercements and fines.
