*Hanne Hachet made a false claim v. the bailiffs of Makelisfeld for toll unjustly levied. Pledge, Henry Bryan*¹⁴⁷

...

Richard de Stokeport, whose liberty had been taken into the king's hands at the last eyre, was charged with having since taken the emends of bread and ale in Stokeport. This he could not deny and he was amerced. Pledges, Henry Biran and John de . . . ton. The bailiff of the liberty of Makelisfeld was ordered to take that liberty into the king's hand (½ mark).

William de Scriggel' made fine for the inquisition on which he put himself concerning a suspected trespass in the forest. Pledge, Henry Biran.

An undated charter by which Henry Sparry quitclaimed to Adam del Deane in the land that William Sparry, Henry's father, held in Lower Hurdsfield, was witnessed by both Thomas the clerk then bailiff of Macclesfield and Henry Byran, as was a matching charter by which Henry quitclaimed to Adam son of Richard Brown of Deane all the land that William his father had held in Little Hurdsfield.

Thomas the clerk, bailiff of Macclesfield, witnessed an undated charter by which Alexander de Hurdsfield and Matilda his wife granted to Adam de Deane a plot of land called Ulricsisle in the territory of Hurdsfield, to wit two thirds of that isle. Henry Byran and Roger the vicar of Prestbury were also among the witnesses.
