Order not to intermeddle further with the lands that Thomas de Aldithelegh, who died a minor in the king's wardship, held of other lords than the king, retaining the third part of two parts of the manor of la Newehalle and the ninth part of Nantwich (Wych Mauban), which are in the king's hands by reason of the minority of Nicholas, brother and heir of the said Thomas.

4 March 1309 Westminster Close Roll 2 Edward II m.10 [99]

To Stephen le Blund, escheator in Cheshire. Order to resume into the king's hands and not to intermeddle further with the lands held of other lords than the king by Thomas de Aldithelegh, who died under age in the king's wardship, a tenant in chief of the king of a third of two parts of the manor of la Newehall and a ninth part of Nantwich (Wyche Mauban) which are now in the king's wardship by reason of the minority of Nicholas, brother and heir of the said Thomas, it being found by inquisition that the said Thomas held no other lands in chief of the king in that county; whereupon the king ordered the said escheator not to intermeddle further with the lands that the said Thomas held in that county of other lords, retaining in the king's hands the lands in la Newehall and Nantwich; to which the said escheator returned that he had delivered, long before the writ reached him, the lands aforesaid to Peter de Gavaston, earl of Cornwall, by virtue of another writ of the king's that had previously reached him, so that he could do nothing in execution of the last writ.
