John son of Richard le Catchpole sued William Cartegore for withholding six lead vats which belonged to him as part of his inheritance of a messuage in Wych Malbanc, descending to him after the death of his brother. William said that John's brother left the vats to him: the jury agreed.

In April 1307 a set of tenants, including Robert son of Richard Catchpole, recognized a debt of 108s to Richard de Fowlhurst, presumably for farm of his property and rights in Wych Malbanc.
